Wondering if you have received clarification regarding the CISWRA budget?

There are some expenses that were approved in the original budget that we would like to access to continue the work through Sept. 26 (my last day); e.g. we have a contract with Dr. Anderson that terminates in August, so we will need to pay him; also our plans for the next couple of months have included convening in-person meetings with scientists and community groups to talk about next steps.
