Re: Protect Colorado from Unnecessary Use of Harmful Insecticides

Dear Chairs and Members of the Colorado Senate and House Agriculture Committees:

The undersigned businesses, organizations, and individuals urge you to pass legislation to protect Colorado from harmful and unnecessary uses of systemic insecticides, including neurotoxic neonicotinoids (“neonics”). Neonic pollution continues to worsen in Colorado, and the state must act swiftly to protect Coloradans – especially children – and our soil, water, and animals.

Systemic insecticides threaten Colorado’s wildlife and natural resources. These chemicals often persist in the environment for years and move easily into water, soil, and plants. Neonics have been [found in Colorado water](#) at 100x levels known to harm aquatic life – and at levels beyond the U.S. EPA’s worst-case estimates for groundwater contamination from neonics. Research connects neonic levels commonly found in Colorado to the collapse of fisheries, mass losses of birds, harm to pollinators, and birth defects in deer.

The loss of biodiversity from systemic insecticide pollution puts Colorado’s food security and agricultural economy at risk. [Pollinators](#) contribute to billions of dollars of Colorado agricultural production, including crops ranging from Palisade peaches and Rocky Ford cantaloupes to beans, sunflowers, and alfalfa. Even self-pollinating plants, like Pueblo green chiles, depend on Colorado’s native bees to thrive. Commercial beekeepers in Colorado lost an [average of 42%](#) of their hives from June 2024 to March 2025, and studies confirm that neonics are driving pollinator declines. In addition, neonics harm earthworms, beneficial bacteria, and other life that keeps our soils healthy and productive.

Neonic pollution also directly threatens our health. Coloradans are exposed to neonics through food, water, workplaces, and in the environment. A study of pregnant women across the U.S. found neonics in over 95% of participants. Neonic exposure during pregnancy is linked to birth defects of the heart and brain, and other developmental issues. Adult exposures are also associated with neurological and reproductive issues, including decreased testosterone and sperm count.

The good news: we can protect Colorado by eliminating the vast majority of systemic insecticide pollution, which comes from unnecessary uses. Farmers of corn, wheat, and other crops are often forced to pay for seeds that are automatically coated with neonics, even though extensive research shows this typically provides “no overall economic

benefit" to farmers. In our urban and suburban spaces, neonics are applied needlessly to turf and gardens, even when there is no real pest threat. New York, Vermont, Ontario, and Québec have already acted to curb unnecessary uses, by permitting them only where needed to address an actual pest problem. In Québec, this need-based approach has essentially eliminated the use of neonic-treated seed for major field crops. Colorado also needs to take action.

The risks of leaving systemic insecticide pollution unaddressed are playing out in real time. We urge you to join other forward-thinking leaders across the continent and reverse contamination trends by eliminating unnecessary use of systemic insecticides.
